Vale Professor Susan Campbell

Professor Susan Campbell AM passed away on 3 March 2011. Professor Campbell was a long-serving and highly respected member of the Faculty of Law at Monash University, my alma mater. In 2006, Professor Campbell headed the State Government's review of legal education, which resulted in, among other reforms, the replacement of articles of clerkship with legal traineeships. Professor Campbell was also an instrumental figure in the development of community legal centres and clinical legal education.

Her accomplishments are too extensive to detail here but suffice to say the legal community has lost a wonderful ambassador. On behalf of Victorian Women Lawyers, I offer my condolences to Professor Campbell's family, friends, colleagues and students. She will be deeply missed.

International Women's Day Breakfast, 3 March

UN Women Australia (formerly UNIFEM Australia) brought in the 100th year of International Women's Day celebrations with a breakfast on 3 March at the Melbourne Convention and Exhibition Centre, kicking off what is now dubbed International Women's Week.

Astrid Haban-Ber (Immediate Past Convenor) and Patricia Athanasiadis (Assistant Convenor) joined with women and more than a token male to hear guest speakers Unity Dow, the first female justice appointed to the High Court of Botswana and Sekai Shand, former spokesperson for World Vision and current board member of Action Aid Australia, address struggles they faced individually and the changes they effected. Unity also humorously exclaimed that she awaits the 200th year of International Women's Day celebrations, when women won't have a speaker that is the "first" of anything.

Proceeds raised from UN Women Australia's fundraising efforts will go towards UN Women projects that promote female political participation and leadership. UN Women works to train women to run for parliament, providing them with the technical and financial assistance necessary to overcome barriers to female leadership and to seeking office. Promoting women in leadership promotes the representation of concerns of women and female role models for the next generation.

Kirstie Parker, Editor of the Koori Mail and board member of Reconciliation Australia gave the keynote address. Kirstie's inspiring comments on the evolution of Indigenous life and the work that still remains to be done on reconciliation in Australia included the importance of women in bringing about change. Also speaking was Rachael Mazawith a performer from The Black Arm Band, who treated the audience to a rendition of a poem by Oodgeroo Noonuccal titled *Son of Mine*, leaving attendees speechless. Lisa Hunt, Chair of the Melbourne Chapter of UN Women Australia made concluding remarks on the role of UN Women and how the organisation effects change globally. MC Pauline Whyman had the audience in stitches throughout with her anecdotes and insightful introductions.

A key mentor who influenced my career is... my late father, who could always see the big picture.

If I wasn't a lawyer... I would establish another type of service-oriented business.

Before I started at my present position... I was a Senior Associate (Industrial Relations and Employment) and Pro-Bono Co-ordinator at Blake Dawson.

The best advice I ever received was... from my parents, which was to follow my heart in choosing my courses at university (initially, Arts, and later Law).

One of the key legal initiatives I am involved in is... is the implementation of flexible practices in the workplace

Outside of the law I enjoy... I love socialising with family and friends, swimming, jogging, singing (enthusiastically rather than with talent!), listening to live music, and attending art exhibitions.

This month we profile **Emily Collin, solicitor** in the **Property, Construction and Environment team** at [Mallesons Stephen Jaques](#):

I became a lawyer because... I thought getting paid to argue sounded like a good idea. Three years in as a commercial property and development lawyer and I am not sure this would be the most accurate description of what I do. However, I do really enjoy the technical challenges that come up in my day to day practice – particularly in negotiating and documenting novel arrangements for clients.

I am really proud of... the technical expertise, professionalism and good humour of the partners and lawyers at my firm.

You can have it all... but don't complain if you get indigestion.

I am extremely grateful for... my health.

A key mentor who influenced my career is... a partner in my group who supervised me for the first few months of my articles year and with whom I continue to work closely. I had not given much thought to becoming a property lawyer, and a major reason why I chose to permanently work in Mallesons' commercial property group was the opportunity to learn from her and other highly skilled practitioners in the group.

If I wasn't a lawyer... I wouldn't be the black sheep of a family of doctors!

Before I started at my present position... I was a uni student and part time legal secretary for a sole practitioner who ran a French speaking practice, combining my two favourite academic pursuits (law and languages).

The best advice I ever received was... if you are doing a piece of work, take the time to do it thoroughly and carefully. It is very easy to do a rush job and very easy for clients to pick up that you have done so.

One of the key legal initiatives I am involved in is... the Lawmail programme run by the National Children's and Youth Law Centre. Volunteers, including many from Mallesons, answer legal questions sent in by children across Australia. It is fantastic that young people, who would otherwise have very limited access to legal advice, are able to use this service.

Outside of the law... I love cooking. It is a great way to switch off from work mode, even (or especially) after a long day in the office.
