


### KYLIE KILGOUR DEPUTY SECRETARY DEPARTMENT OF JUSTICE AND REGULATION

Kylie joined the Victorian Department of Justice and Regulation in 2006 and is currently the Deputy Secretary, Criminal Justice Strategy and Co-ordination.

She leads complex reform projects across the criminal justice system, including the Department's response to the Victorian Royal Commission into Family Violence and the Commonwealth Royal Commission into Institutional Child Sex Abuse

Prior to joining the department, Kylie worked in community legal centres in NSW and the UK Legal Services Commission



# ANNA BROWN DIRECTOR OF LEGAL ADVOCACY HUMAN RIGHTS LAW CENTRE

Anna is the Director of Legal Advocacy at the Human Rights Law Centre.

She has been involved in many recent LGBTI reforms, including marriage equality, access to treatment for young trans people, recognition of sex and gender diversity, discrimination protections, and erasing historical convictions for homosexual offences.

Anna is also Co-Chair of the Equality Campaign and of the Justice Working Group of the Victorian Government LGBTI Taskforce.



#### SARAH FEAGAN LIVING POSITIVE VICTORIA

Sarah is a queer woman who has been living with HIV for over 10 years. She is vocal about her struggles living with HIV, and uses her experiences to educate and inspire. She has recently stepped down as Chair of Positive Women Victoria to join the new Peer Navigation Program at Living Positive Victoria.

Sarah also sits on the Board of the National Association of People Living with HIV Australia. She is also co-facilitator of the Positive Leadership Development Institute and Phoenix for Women, a workshop for newly diagnosed women.

Sarah is a strong advocate for peer based services using the MIPA and MIWA principles to inform her practice and hopes to see a future without stigma for people living with HIV.
