Louise Johnson | CEO, Victorian Assisted Reproductive Treatment Authority (VARTA)

Louise has been the Chief Executive Officer of the VARTA since 2005. Louise holds an Honours degree in microbiology, postgraduate qualifications in education and management, a Masters in Regulatory Studies and is a graduate of the Australian Institute of Company Directors. Louise has worked extensively in the public health and education sectors and is a community member of the Occupational Therapy Board of Australia, member of the NHMRC Embryo Licensing Committee, and a past chairperson for Women's Health Victoria.



Jane Bennett is a social worker, researcher, writer and renowned menstrual educator. Jane is the creator of several programs designed to support girls in their journey into womanhood and has authored multiple texts on the topics of menstruation, menopause, fertility and contraception. Jane has also worked extensively with the Victorian Women's Trust, most recently co-authoring a book titled "About Bloody Time: the menstrual revolution we have to have" as part of the gender equality project and the harm prevention entity of VWT, the Dugdale Trust for Women and Girls.
