Keynote Speaker Kylie Kilgour Deputy Commissioner IBAC

Kylie Kilgour is currently a Deputy Commissioner at the Independent Broad-based Anti-corruption Commission (IBAC), primarily focussed on its police oversight functions. In 2019 & 2020 Kylie was the CEO of the Royal Commission into the Management of Police Informants. From 2006 to 2018 she worked at the Department of Justice and Community Safety on a wide range of justice reform projects, including in relation to the legal profession, civil justice, court programs, family violence and the criminal justice system. Prior to joining the Victorian public service, Kylie worked in community legal centres in NSW and legal aid in the UK. She has a Bachelor of Arts/Law from the University of NSW and was admitted to practice as a legal practitioner in 2001.
