**Molina Asthana** is on the board of, and was the first South Asian woman to be elected President Elect of the Law Institute of Victoria. She is also the National President of the Asian Australian Lawyers Association. She is an experienced commercial lawyer having practiced at top-tier Australia law firms and the Victorian Government Solicitor's Office and in the Supreme Court of India. Molina also serves on various boards and is the co-founder of the Asian Australian Alliance and the founder of the organisation Multicultural Women in Sport.



**Rabea Khan** is a barrister who works primarily in criminal and regulatory law. Prior to joining the Bar, Rabea worked as a solicitor for the Director of Public Prosecutions in Sydney, the Victorian Aboriginal Legal Service, IBAC and the Office of Public Prosecutions in Melbourne. Rabea is a past Vice-President of the Muslim Legal Network (NSW) and was on the Review Advisory Committee for the Review of Sexual Harassment in Victorian Courts. She is currently a member of the Independent Pandemic Management Advisory Committee appointed by the Minister of Health.



**Monisha Saqueria** is a Partner at Allens' Disputes and Investigations teams, with expertise in tax and general commercial disputes, including class actions. In Australia, she has primarily assisted various mining and oil and gas companies with respect to regulatory matters and contract disputes - acting for them in arbitrations, mediations and in various courts in Australia.
